### Experience

**Mitigating charges for a defendant in a headline-grabbing case:** Represented an individual indicted in a highly publicized criminal RICO conspiracy matter. Through oral advocacy, presentations, and evidence gathering, Amanda and her team successfully placed the client's role among the five other defendants in context and persuaded the government to significantly reduce the charges to a single count of fraud. While the individual initially faced a felony conviction carrying significant jail time, she was ultimately sentenced to a short term of probation.

Advocating for the rights of pro se litigants: Successfully handled an appeal pro bono of a dismissed Section 1983 case for an indigent individual. The case had been dismissed for failure to prosecute as well as the client's failure to pay a sanction imposed. Amanda argued the matter in the U.S. Court of Appeals for the Second Circuit and won, convincing the court to reverse the district court's holding and vacate the judgment dismissing the case. The Second Circuit also vacated the lower court's imposition of a sanction, holding that it did not comport with the client's due process rights, a decision that helps safeguard the rights of indigent pro se litigants.

**Nipping two lawsuits in the bud:** Represented a Greek shipping company's chairman of the board in a securities class action and a separate suit alleging breach of fiduciary duties. Amanda's team prevailed by getting both cases dismissed, achieving swift relief to avoid what would have been long, protracted, and costly lawsuits.

Received a favorable ruling on a motion for judgment on the pleadings. The court dismissed virtually all of the opposing party's counterclaims and granted Sher Tremonte's motion to limit discovery and expedite resolution of any dispositive issues on summary judgment. The ruling gave the firm's client a clear path to resolve the remaining issues quickly, removing from discovery any number of potentially distracting issues that might be found in the partnership's 30-year history. The parties entered into a favorable settlement soon thereafter.

Successfully turning the tables on a breach of contract suit: Represented a celebrity client being sued in federal court for allegedly breaching an endorsement contract with a designer jewelry brand. Amanda successfully countersued for breach of contract for the plaintiff's failure to compensate her client under the endorsement contract, earning her client a favorable settlement.

Coordinating with outside entities in an investigation: Representing a large, multinational utility company in responding to federal grand jury subpoenas in connection with a bribery kickback scheme. In addition to liaising with the government on an ongoing basis, Amanda worked with a Big Four accounting firm to employ various investigative techniques to uncover the fraud.

Saving a client from indictment in two federal district courts: Represented a criminal client facing indictment in first the Southern District, then the Eastern District of New York. Through effective oral arguments, Amanda and her team demonstrated that her client did not deserve to be charged and convinced the government not to indict.
